

Covid-19 rules for the Hlinka Gretzky Cup 2021

Prevention

- The health of everyone on site is of the utmost priority; a great deal of solidarity and personal responsibility are assumed.
- People with Covid-19 symptoms cannot attend the event.
- If Covid-19 is later diagnosed (within a maximum of 14 days), the organizer must be notified immediately via email office@czehockey.cz or phone 737 822 386.
- The declaration (see below) must be completed truthfully.

Protective measures

The three most important protective measures are:

- Face protection: FFP2 / KN95 respirators must be worn at the event at all times except for onice training.
- Hand hygiene: Wash your hands regularly with soap and water and always sanitize your hands before putting on or taking off the respirator.
- Keep your distance: A distance of 2 metres or more from each other. Keeping distance is especially important indoors and when eating.

Entry to the ice arena

During the event, only persons who have an accreditation issued by the organizer or have a ticket / season ticket for the game / game day will be allowed to enter the ice arena.

To obtain accreditation or to be allowed entry to the game / game day, all season ticket or single ticket holders will also need to provide proof of being infection-free in accordance with current government regulations. That means having one of the following documents:

- a negative PCR test result not older than seven days
- a negative antigen test result not older than 72 hours
- confirmation of vaccination against COVID-19 (at least 14 days after the second dose)
- confirmation of having had COVID-19 within the last 180 days

Personal responsibility

All participants must show a high degree of personal responsibility when observing the measures for holding the event!

The organizer is responsible for checking compliance with the defined measures.

Participants must strictly observe the prescribed measures and report any signs of illness immediately.

Declaration

A declaration must be signed to obtain accreditation for the event, otherwise accreditation will be denied. This ensures individual training for all participants of the event. The declaration must be filled in truthfully.

Appendix 1 - Declaration

Contact tracing

Complete contact tracing for close contacts is the main task of the organizer. A close contact is considered to be when people are together for more than 15 minutes or repeatedly cross the minimum distance of 2 metres without protective equipment.

The following are used during contact tracing:

- Lists of all those present, except spectators, are guaranteed by accreditation. These lists shall
 be kept for up to 14 days after the event and can be handed over to the health authorities if
 necessary.
- In order to carry out contact tracing, personal data will be processed to the minimum extent
 possible. These data will be secured pursuant to Article 32 of the GDPR and are used solely
 for the purpose of protecting the health of all those present. They will be deleted after their
 purpose has been met.

Procedure in the event of symptoms

If symptoms appear, it is important to stay away from the event's grounds at all costs. The procedure is as follows:

- If symptoms appear, the team leader/manager must be informed immediately.
- The person concerned will be placed in quarantine.
- The team leader/manager will immediately inform the organizer's responsible person.

The responsible person will decide on the next course of action based on the instructions of the relevant public health office.

Travel requirements

Due to the Covid-19 pandemic, there are special regulations for entering the Czech Republic. If you are traveling to the event from abroad, please follow the instructions of the Ministry of Foreign Affairs of the Czech Republic.
